ENVIRONMENTAL & NET ZERO POLICY COMMITMENT

- British Land is committed to protecting the environment in which we operate, including the prevention of pollution and the control of significant identified environmental risks, whilst maintaining commercial viability, long-term profitability, and the enhancement of our reputation.
- British Land is committed to decarbonising its business model, with SBTi aligned targets in place for both operational and embodied carbon.

- To report on progress against our objectives, targets and Pathway to Net Zero to enable investors and other stakeholders to make informed decisions on British Land
- To incorporate environmental considerations, including potential impacts on biodiversity and ecosystems, into our processes and procedures and to directly mitigate or adapt our operations to reduce climate change.
- To use our influence to improve environmental performance in our supply chain and encourage purchasing of sustainable resources and materials.
- To promote efficient use of resources and to promote the minimisation, re-use and recycling of waste arising from our activities.
- To promote the responsible use of water and minimise the severity of leakages.
- To identify and monitor climate risks through updating modelling every three years and appropriately mitigate against those risks through the development and implementation of climate resilience action plans.
- To comply with all applicable legal requirements.
